Welcome to Victoria’s beginner hockey league! We are a non-contact, adult recreational hockey league. The season starts in September and ends in April. Our goal is to provide a clean, safe, and social environment for adults to learn how to play hockey.

All players must be at least 19 years old to play. Full hockey equipment is mandatory including a minimum face protection of a half-visor (shoulder pads must be worn as well).

Team Registration: \$8000/Team by May 15

10% deposit (\$800) required to hold a team spot by May 15. 50% (\$4000) team fees are due before August 31/10. Remaining 40% (\$3200) due before November 30/11. Team deposits are lost if a team does not make a total 50% payment on or before August 31/11.

Individual Registration: \$580/Player (\$290/goalie)

50% (\$290) deposit is required to reserve a spot. 50% (\$290) remainder before September 1, 2011. The league will notify which team you are placed on before season start via email.

I am aware that ice hockey is a physical, contact sport, and playing ice hockey in a hockey league involves many risks, dangers and hazards including, but not limited to: impact and collision with other players, officials, objects or equipment used in connection with playing ice hockey; changes in the type of surface and the condition of each surface in the building; failure to play safely within one's own ability; failure to play against others of equal stature or ability; theft; negligence of other players; playing with or without officials. Included in these risks are any negligence on the part of Chris Yue, Eric Yue and ISLAND HOCKEY 101 INC. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage, expense and related loss including loss of income, and other loss resulting there from.

RELEASE OF LIABILITY AND WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

In participating in the Island Hockey 101 INC. of 2011/2012 organized by Chris Yue and Eric Yue, I hereby agree to the following:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against Chris Yue, Eric Yue and Island Hockey 101 INC., their representatives and executives, and to release the releasees from any and all liability for any loss, damage, injury of expense that I may suffer, or that my next of kin may suffer as a result of my use of or my participation in the Island Hockey 101 business hockey league due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care.
2. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.
3. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia.
4. Any litigation involving the parties to this Agreement shall be brought within the Province of British Columbia.

In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

I have read and understand this agreement and I am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, assigns and representatives may have against the releasees.
